Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the Promotion is deemed acceptance of these Terms and Conditions.
2. This Promotion is a game of skill. Chance plays no part in determining the winner.
3. Entry is open to all residents of Australia and New Zealand aged 18 years or over.
4. Employees and their immediate families of CLA Trading Pty Ltd (trading as Europcar Australia) ("The Promoter"), NBL and their associated agencies are not eligible to enter.
